- Eliminate all forms of violence against all women and girls in the public and private spheres, including trafficking and sexual and other types of exploitation.
- Eliminate all harmful practices, such as child, early and forced marriage and female genital mutilation.

New ITR forms for AY 2018-19: Things you must know before you file returns

The Central Board of Direct Taxes (CBDT) on Thursday released a one-page simplified Income Tax Returns (ITR) Form-1(Sahaj) for the assessment year 2018-19, similar to that of the previous assessment year. This initiative, the CBDT said, benefitted around 30 million taxpayers who filed their returns in this simplified Form. However, this year, the tax department wants ITR assessees to provide their salary breakup and businessmen their GST number and turnover. All the seven ITRs are to be filed electronically except for some category of taxpayers, the Central Board of Direct Taxes (CBDT) said in a statement.

### Here's what Income Tax Returns (ITR) assessee must know:

The new Sahaj form wants you to disclose specific details about your salary. It seeks an assessee's salary details in separate fields and in a breakup format such as allowances that are not exempt, value of perquisites, profit in lieu of salary and deductions claimed under section 16. Though these details are provided in the Form 16 of a salaried employee, now they have to be mentioned in the tax return for clarity of deductions. Sahaj form will be used by over 30 million taxpayers.

#### Who has to fill Sahaj form:

Sahaj form will be filled by individuals whose income is up to Rs 5 million from the following sources:

- \* Income from Salary/Pension
- \* Income from One House Property (excluding cases where the loss is brought forward from previous years)

- \* Income from Other Sources (excluding winning from Lottery and Income from Race Horses)
- \* In case of clubbed Income Tax Returns, where a spouse or a minor is included, this can be done only if their income too is limited to the above specifications.

#### What is the structure of ITR 1 Form?

Part A – General Information

Part B-Gross total Income

Part C – Deductions and taxable total income

Part D - Computation of Tax Payable

Part E – Other Information

Schedule IT – Detail of Advance tax and Self Assessment Tax payments

Schedule TDS – Detail of TDS/TCS

#### ITR Form-2 has been rationalised:

Individuals and HUFs with income under any head other than business or profession shall be eligible to file ITR Form-2

The Individuals and Hindu Undivided Family (HUFs) having income under the head business or profession shall file either ITR Form-3 or ITR Form-4 (in presumptive income cases).

#### Who can use ITR-4 Sugam?

This Return Form is to be used by an individual/ HUF/ Partnership Firm whose total income for the assessment year 2017-18 includes:-

- (a) Business income where such income is computed in accordance with special provisions referred to in sections 44AD and 44AE of the Act for computation of business income; or
- (b) Income from Profession where such income is computed in accordance with special provisions referred to in sections 44ADA; or

- (c) Salary/Pension; or
- (d) Income from One House Property (excluding cases where the loss is brought forward from previous years); or
- (e) Income from Other Sources (excluding Winning from Lottery and Income from Race Horses).

# Who can file ITR Form-1 (Sahaj) or ITR-4 (Sugam) in paper form

CBDT said where the return is furnished in ITR Form-1 (Sahaj) or ITR-4 (Sugam), the following persons have an option to file the return in paper form:-

- An individual of the age of 80 years or more at any time during the previous year; or
- An individual or HUF whose income does not exceed 500,000 rupees and who has not claimed any refund in the Return of Income.

ITR for non-resident Indians: In case of non-residents, the requirement of furnishing details of anyone foreign Bank Account has been provided for the purpose of credit of refund.

No details of cash deposit required for ITR: The requirement of furnishing details of cash deposit made during a specified period as provided in ITR Form for the Assessment Year 2017-18 has been done away with from Assessment Year 2018-19.

Significance of Ethics in Education

Education is not knowledge alone, but also the capacity to utilize it. The quality of education depends on the ability it imparts to make proper use of the learning. In other words, acquiring knowledge coupled with the ability for its proper application is the real education. As such, the traits, which impart the skill of applying the acquired knowledge, are of

great significance; without the requisite skill of application, the knowledge is a mere treasure trove in a sealed vault. Education includes all that which completes the personality of an aware and cultured citizen.

True education must, therefore, provide also the skill for application and enable development of the traits, which nurture its future growth. The ethical component of education is an element, which caters to this need. It is in the different ethical values of the knowledge makers that we find the cause for the difference in their contribution, even though they are equipped with the same level of knowledge.

The purpose of education is to produce knowledge makers with the capacity of making the most profitable use of the acquired knowledge. In his convocation address (1922) at the Calcutta University, Sir Asutosh Mookerji, describing the aim, purpose and true functions of the University in the life of a nation, said:

"To my mind the University is a great storehouse of learning, a great bureau of standards, a great workshop of knowledge, a great laboratory for the training as well of men of thoughts as of men of action. The Univesity is thus the instrument of the state for the conservation of knowledge, for the discovery of knowledge, for the distribution of knowledge, and above all, for the creation of knowledge-makers."

Today education must fulfill the realization of the needs and ideals of the society. Government must transform itself into an agency of society from its role as an instrument of power. National institutions must catalyze the process of social change. The ideals must become the aims of education in our socialist, secular, republican democratic polity.

Individual purity of character alone can revive the parched field, let's regain our good character quickly and all will be well – politics, administration and economic conditions." This exhortation assumes greater significance with the passage of time. Ethical component of education to equip the future.

Generations to meet the growing challenges is the only effective answer. All education must, therefore, be ethics oriented to equip the future nation builders for the performance of their task. The real purpose of education must be fulfilled.

CBSE UGC NET Qualifying Criteria
July 2018 Latest Changes

With the ongoing debate on the reservation, the UGC has decided to change the selection criteria for the candidates appearing for the Net Exam.

UGC has decided that 6% of the candidates appearing for the NET Exam will be declared as qualifying to be eligible for the entry level post of Assistant Professor and the Reservation Policy as per the category will be applied to this 6% qualified candidates.

Top 6% of the candidates who take the exam (all three papers) and score minimum 40% aggregate marks (at least 35% aggregate marks for candidates belonging to social groups viz., Scheduled Castes / Scheduled Tribes/ Other Backward Classes (Non-creamy layer)/ People with Disabilities) will be eligible for Assistant Professor.

As per the estimates by UGC data trends of last two decades, around 68% to 92% candidates qualifying UGC NET Exam are from the reserved category.
